**COMPLAINT FOR DAMAGES AND JURY DEMAND**

COMES NOW Plaintiff, Lorie Price, by counsel, Lewis & Kappes, P.C., for her claim for relief against the Defendants, Lease Domains, Inc., Domain Sponsor.com, and Oversee.net (collectively the "Defendants"), and states as follows:

**Introduction**

This action arises out of the Defendants' infringement of Ms. Price's protected trademarks registered pursuant to Indiana statute. Those trademarks, known as "N2Touch" and "N2Touch.com" (with the ".com" disclaimed), have been used by the Defendants, individually and collectively, to promote their own commercial interests. The infringing activity has included taking control of the Internet domain name "N2Touch.com", offering such domain name for resell, including resale to Ms. Price, as well as using the domain name to direct traffic to other websites promoting commercial activities similar to that engaged in by Ms. Price. In addition, certain Defendants have

misappropriated Ms. Price's name, but placing her name on the website located at the domain "N2Touch.com" in an effort to attract commercial internet traffic.

**Venue and Jurisdiction**

1. The Plaintiff is a resident of Cory, Clay County, Indiana.
2. Upon information and belief the Defendant, Lease Domains, Inc. is a corporation organized under the laws of the State of Illinois with its principal place of business in Illinois, but which conducts business in the State of Indiana.
3. Upon information and belief the Defendant Oversee.net, is a corporation organized under the laws of the State of California with its principal place of business in California, but which conducts business in the State of Indiana.
4. Upon information and belief, the Defendant Domain Sponsor.com is a subsidiary of Oversee.net, is a business engaged in the business of "domain monetization", incorporated under the laws of the State of California, with its principal place of business located at 515 S. Flower Street, Suite 4400, Los Angeles, California, 90071, but which conducts business in the State of Indiana.
5. Venue is proper in Marion County, Indiana pursuant to Indiana Rule of Trial Procedure 75A.
6. This Court has personal jurisdiction over each of the Defendants as each is in the business of selling, registering, and/or "monetizing" domain names and registrations over the Internet. Each Defendant has, at one time or another, offered the sale of the domain name "N2Touch.com", which is a trademark registered pursuant to Indiana Code §24-2-1-1 *et seq.* Further, the Defendants, particularly Domain Sponsor.com and Oversee.net, have deliberately associated the domain name

"N2Touch.com" with other business ventures in Indiana, and have deliberately attempted to draw internet traffic from Indiana to the site for their own commercial purposes. The Defendants continue to made offers to sell the domain name, "N2Touch.com" to third parties, including to residents of the State of Indiana, and have previously made such an offer to Ms. Price. In addition, the Defendants have appropriated Ms. Price's name in order to attract potential buyers to their site, and to redirect traffic away from Ms. Price's business. All of these activities have caused considerable harm to Ms. Price business and reputation.

**Factual Basis**

6. Ms. Price owns and operates several businesses in the State of Indiana. One of these is known as "N2Touch" which provides a referral service for various therapeutic massage services to residents of this State, including the area in and around Indianapolis, Marion County.

7. In addition to N2Touch, Ms. Price runs her own therapeutic and holistic massage business.

8. Ms. Price has invested considerable time, effort, and expense in developing her businesses, their goodwill, and her personal reputation as a massage therapist.

9. On May 11, 2004, Ms. Price registered as a trademark under Indiana Code Section §24-2-1-1 et seq. with the Office of the Secretary of State of Indiana for a trademark designated "N2Touch". (Exhibit A).

10. Shortly thereafter, on May 17, 2004, Ms. Price registered with the Indiana Offices of the Secretary State under the Indiana Code Section §24-2-1-1 et seq. the trademark "N2Touch.com" with a disclaimer of the term ".com" (Exhibit B).

11. The registration for "N2Touch.com" specifically states that the trademark is to be used in connection with "web based referral service for massage therapy."

12. The registrations for both trademarks expire in May of 2014, and were first used in the State of Indiana in January of 2003.

13. Following the registration of the trademarks, Ms. Price established the website "www. N2Touch.com", which served as a mechanism for operating her massage referral service through the Internet.

14. At some time in 2008, Ms. Price's registration of the domain N2Touch lapsed, and the domain was, upon information and belief, purchased and registered by the Defendant Leased Domains, Inc.

15. In December of 2008, Ms. Price contacted Leased Domains through a site established by the company at the N2Touch domain and notified Leased Domains that the domain name was a registered trademark under Indiana law. In response to that notification Leased Domain responded that it would be willing to sell the domain name to Ms. Price for a price of \$483.00.

16. Ms. Price declined the payment demand and the offer of sale.

17. Subsequent to the exchange between Ms. Price and Leased Domains in December of 2008, upon information and belief, Leased Domains sold or otherwise transferred control of the domain N2Touch to the Defendants Oversee.net and Domain Sponsor.Com. At present, the Defendants Oversee.net and Domain Sponsor.Com have

been operating the site in an effort to "monetize the domain name" and have posted various links on the site that produce results for "related searches" for a variety of commercial services and products, including massage services similar to that offered by Ms. Price, located in Indiana. (A true and accurate copy of the "homepage" for "www.n2touch.com is attached hereto as Exhibit C-1).

18. The links from the homepage are titled: "massage therapist"; "massage"; "touch screen"; "digital camera sale"; "singles"; "married personal"; "older women" "digital photo printing"; "cheap digital camera"; and "microtouch." True and accurate copies of the webpages that appear upon utilizing these links are attached hereto as Exhibits C-2 to C-11. Upon following one of the above named links, several additional links appear. Accessing these links again provides the internet user results for "related searches." Among these additional links are those titled: "prostate massage"; "Indiana massage"; "Lori Price"; "Michelle"; "Indianapolis"; and "Massage sensual." True and accurate copies of the webpages that appear upon utilizing these links are attached hereto as Exhibits C-12 to C-17. Accessing these links (or others which appear from time to time on the webpage) connects the internet user to a variety of third-party commercial websites that offer products and services for sale.

19. Upon information and belief, Domain Sponsor.com has created a search for the name "Lori Price" which links the internet user to multiple commercial websites offering public records searches for Ms. Price, as well as unrelated commercial websites. (Exhibit C-14).

20. Domain Sponsor.com has offered, and continues to offer the sale of the domain name N2Touch.com and "a minimum" offer of \$480.00. (Exhibit D).

21. Since the time that the Defendants took control of the domain name N2Touch.com, the businesses owned and operated by Ms. Price have suffered substantial losses in the number of customers, and in referrals from N2Touch.

22. Those losses have required Ms. Price to terminate referral services with a number of massage therapists, and to seek employment outside the State of Indiana.

**COUNT I**  
**Trademark Infringement**

23. The Plaintiff, Lorie Price, incorporates by reference paragraphs 1 through 22 of the Complaint.

24. N2Touch and N2Touch.com are properly registered trademarks under the Indiana trademark act, Indiana Code Sections §24-2-1-1 et seq.

25. The Defendants have, without the consent of Ms. Price as a registrant, used an exact copy of the marks "N2Touch" and "N2Touch.com", in connection with the offering to sale and distribution and advertisement of goods and services not associated with Ms. Price or the marks.

26. The Defendants have reproduced, counterfeited and copied the protected marks and applied said reproductions, counterfeits and copies to advertisements intended to be used in connection with the sale and distribution of goods and services in the state of Indiana.

27. Such acts are in direct violation of Indiana Code Section §24-2-1-13.

WHEREFORE, Plaintiff Lorie Price is entitled to, and requests, all remedies set forth under Indiana Code Section §24-2-1-14 including profits derived from the unauthorized use of the mark, the damages suffered by Ms. Price due to the Defendants'

infringing uses, the return of the mark and domain name to the possession and control of Ms. Price, as well as all attorneys fees.

**COUNT II**  
**Misappropriation**

28. The Plaintiff, Lorie Price, incorporates by reference paragraphs 1 through 27 of the Complaint.

29. The Defendants Oversee.net and Domain Sponer.Com have misappropriated the Plaintiff's name, Lorie Price, by deliberating posting a similar name, known to be associated with the domain and business name "N2Touch" name on the website, for their own business and commercial benefit as it relates to the monetization of the domain N2Touch.com.

30. For such appropriation, done without the consent of Ms. Price, the Defendants Oversee.net and Domain Sponer.com are liable for the tort of misappropriation.

WHEREFORE, Plaintiff Lorie Price requests damages sufficient to compensate her for misappropriation for name and likeness.

**COUNT III**  
**Common Law Unfair Competition**

31. The Plaintiff, Lorie Price, incorporates by reference paragraphs 1 through 30 of the Complaint.

32. The Plaintiff, Lorie Price, possess a protected property interest in the trademarks N2Touch and N2Touch.com and has invested considerable time and expense in developing a business using those marks, and goodwill associated with such business.

33. The Defendants have used the protected marks and the associated goodwill and unfairly treated them as their own by offering such marks for sale and by associating the marks and goodwill with their own commercial interests, and those of third parties.

34. Such acts have directed customers from Ms. Price and her business towards third parties, some of which are in competition with Ms. Price's business interests.


34. Such acts have caused considerable damage to the property of Ms. Price, her businesses, and the goodwill associated with her businesses.

WHEREFORE through these acts, the Defendants are liable for damages caused by their unfair competition.

WHEREFORE, Plaintiff, Lorie Price, by counsel, Lewis & Kappes, P.C. respectfully request that the Court enter judgment in favor of herself, and against the Defendants, Lease Domains Inc., Domain Sponer.com and Oversee.net, and for relief as specified above.



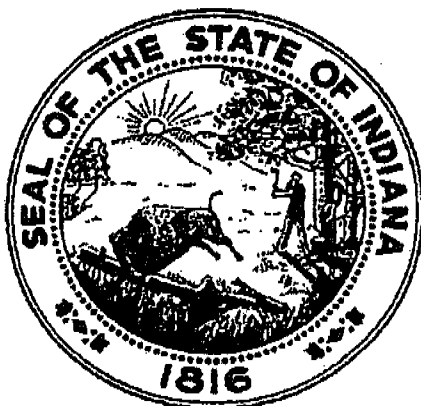

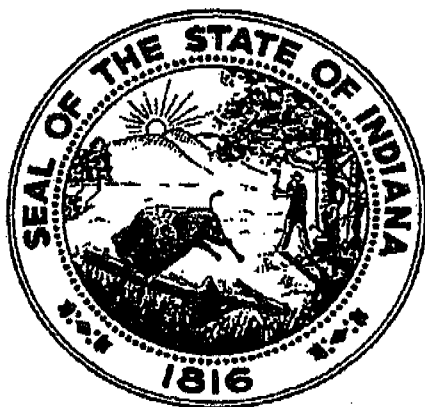
