) **DEMAND FOR JURY TRIAL**

1 Plaintiffs Good Technology Corporation and Good Technology Software,
2 Inc. (collectively, “Good”) allege against defendant Good.Co, Inc. (“Good.co” or
3 “Defendant”) as follows:

4 **JURISDICTION AND VENUE**

5 1. This action arises under the trademark laws of the United States, 15
6 U.S.C. §§ 1114(1)(a), 1125 (a) and (d), and California law.

7 2. The Court has subject matter jurisdiction over Good’s claims for
8 trademark infringement pursuant to 28 U.S.C. §§ 1331 and 1338.

9 3. The Court has supplemental jurisdiction over Good’s claims arising
10 under the laws of the State of California pursuant to 28 U.S.C. § 1367(a).

11 4. Venue in this district is proper pursuant to 28 U.S.C. § 1391(b) and
12 (c) and 1400 (a) because the acts of infringement and other wrongful conduct
13 occurred in the Northern District of California and because Defendant is subject to
14 personal jurisdiction and may be found in this judicial district.

15 **THE PARTIES**

16 5. Good Technology Corporation is a Delaware corporation with its
17 principal place of business at 430 N. Mary Ave., Suite 200, Sunnyvale, California
18 94085.

19 6. Good Technology Software, Inc. is a Delaware corporation with its
20 principal place of business at 430 N. Mary Ave., Suite 200, Sunnyvale, California
21 94085.

22 7. Good.co is a Delaware corporation, registered to do business in
23 California under the name ManageUp.me, with its principal place of business at
24 543 Howard Street, 4th Floor, San Francisco, California 94105.

25 **NATURE OF THE ACTION**

26 **Good and its Asserted Trademarks**

27 8. Good was founded in 1996 and is headquartered in Sunnyvale,
28 California. Since its founding, Good has established itself as a pioneer in mobile

1 technology software and as the leader in its field. More than 6,000 organizations
2 in over 190 countries use Good Technology solutions, including FORTUNE® 100
3 leaders in commercial banking, insurance, healthcare, and aerospace and defense.

4 9. For nearly fifteen years, Good has developed and marketed an ever-
5 expanding family of products using marks that consist of or feature the word
6 “Good,” including the following software products: GOOD WORK™, GOOD
7 FOR ENTERPRISE®, GOOD PRO™, GOOD ACCESS™, GOOD SHARE™,
8 GOOD CONNECT™, GOOD DYNAMICS®, GOOD ENTERPRISE SUITE™,
9 GOOD COLLABORATION SUITE™, and the GOOD MOBILITY SUITE™.


10 These marks appear in and on Good’s products, on Good’s website, in the
11 Google® Play and Apple® App Stores, and on the millions of mobile devices
12 deployed by Good’s more than 6,000 customers. Each week over 2.3 billion
13 messages bearing the notation “Sent by Good (www.good.com)” are sent using
14 Good’s software products.

15 10. In addition to the direct marketing and sale of its software products
16 and professional services, Good also partners with select independent software
17 developers (ISVs). The ISVs develop their own mobile software applications for a
18 variety of purposes and customers. When the ISV applications have been built
19 using Good’s proprietary Good Dynamics® platform, and have passed security
20 testing by an independent third-party laboratory, the ISVs are then authorized to
21 use Good’s trademarks. Good’s licensing of its trademarks to the ISV is its
22 *imprimatur* that the ISV applications are protected by the highest level security
23 features that customers have come to expect from the Good brand.

24 11. In addition to its widespread use of marks consisting of or featuring
25 the word “Good,” Good owns a number of trademark registrations across
26 numerous categories of goods and services including the following representative
27 registrations (the “GOOD Marks”):

12. Attached as **Exhibit A** and incorporated in full by this reference are true copies of the federal trademark registrations for the GOOD Marks.

13. Good began using the GOOD Marks as early as August 2001 and since that time has used the GOOD Marks continuously in connection with its mobile software applications and other products and services.

14. The GOOD Marks are owned by Good, were duly issued in compliance with the law, and are valid and subsisting. Further, many of these registrations have become incontestable, including Good’s registration covering Good’s core GOOD word mark (Reg. 3,318,887).

15. Pursuant to 15 U.S.C. § 1072, Defendant has had constructive notice of Good’s claim of ownership in and to the GOOD Marks.

16. Good has spent millions of dollars establishing the Good brand and the GOOD Marks in the minds of its customers and members of the public. As a result of Good’s continuous use, extensive sales, advertising and promotion of the GOOD Marks, these marks enjoy worldwide recognition and the goods and services they are associated with are recognized by the public as emanating from Good.

1 17. Good maintains a website, www.good.com, where information about
2 Good and its longstanding use of the GOOD Marks can be found.

3 **Defendants Knowingly Adopted Confusingly Similar Marks**

4 18. According to the website of the Delaware Department of State,
5 Division of Corporations, Good.co was incorporated in or about August 2012.
6 According to the California Secretary of State website, Good.co registered to do
7 business in California under the corporate name Manageup.me in or about
8 December 2012.

9 19. Like Good, Defendant offers software applications and related
10 services. Also like Good, Defendant targets not only end-user consumers but also
11 companies, as evidenced by its promotion of “employer solutions” on Defendant’s
12 website located at www.good.co.

13 20. Defendant should have performed a trademark search before adopting
14 the name Good.co. Had it done so, it would have discovered the GOOD Marks
15 and that Good has been registering and using the GOOD Marks since 2001.

16 21. According to Defendant’s website, in approximately March of 2013
17 Defendant changed its corporate name from Manageup.Me and now operates
18 under the business name Good.co.

19 22. At the time of the name change, Defendant knew, or should have
20 known, of Good’s prior rights in the GOOD Marks.

21 23. Defendant’s corporate headquarters are located approximately forty
22 (40) miles from Good’s corporate headquarters.

23 24. Defendant’s URL (www.good.co) differs from the URL for Good’s
24 corporate website (www.good.com) by only a single letter. Internet users
25 searching for information about Good’s company, products, and services can
26 easily find themselves on Defendant’s website by simply failing to type the final
27 letter. In fact, as of January 27, 2015, entering “Good.co” in the Yahoo!® search
28 engine results in Good’s website – not Defendant’s website - being returned as the

1 first result. Such fact could not reasonably have been lost on Defendant when it
2 made the decision to change its business name from Manageup.Me to Good.co.

3 25. As alleged below in detail, Defendant has infringed the GOOD
4 Marks by selecting and using a confusingly similar mark.

5 **FIRST CLAIM FOR RELIEF**

6 **(Trademark Infringement pursuant to 15 U.S.C. § 1114(1)(a) and**
7 **§ 1125(a)(1)(A))**

8 26. Good repeats and re-alleges paragraphs 1 through 25 of the
9 Complaint as if fully set forth herein.

10 27. Since August 2001, Good continuously has used the GOOD Marks to
11 identify its products, including application software. Good uses the GOOD Marks
12 throughout the United States on and in connection with its products and services
13 including in advertising and other promotional materials and on its website
14 www.good.com.

15 28. Defendant's unauthorized use of the GOOD Marks creates a
16 likelihood of confusion, mistake, or deception among members of the public. It is
17 likely to cause the public to believe incorrectly that Good originated, sponsored,
18 or approved Defendant's goods or services, or that Defendant is a Good-
19 sponsored ISV or otherwise affiliated with, connected to, or associated with Good.

20 29. Good is informed and believes, and upon that basis alleges, that
21 Defendant changed its business name and uses the GOOD Marks in a deliberate
22 and intentional effort to confuse the public as to the source of Defendant's goods
23 or services and to reap the benefit of Good's goodwill associated with the GOOD
24 Marks. Good.co knew or should have known that the GOOD Marks were already
25 federally registered at the time it started infringing those marks and would have
26 discovered the GOOD Marks had it conducted a reasonable investigation. Good
27 believes that Defendant chose a confusingly similar name to trade off the goodwill
28 Good established by its prominent use of the GOOD Marks for over a decade.

1 30. On September 16, 2014, Good requested that Defendant cease and
2 desist from its acts of trademark infringement, but Defendant has refused.

3 31. As a direct and proximate result of Defendant's willful and unlawful
4 conduct, Good has been injured and will continue to suffer injury to its business
5 and reputation unless Defendant is restrained by the Court from infringing the
6 GOOD Marks. It would be difficult to ascertain the amount of compensation
7 which could afford Good adequate relief for such continuing acts. Good's remedy
8 at law is not adequate to compensate it for the injuries threatened.

9 32. In light of the foregoing, Good is entitled to injunctive relief
10 prohibiting Defendant from using the GOOD Marks or confusingly similar marks
11 and to recover from Defendant all damages that Good has and will sustain as a
12 result of such infringing acts, and all gains, profits and advantages obtained by
13 Defendant as a result thereof, in an amount not yet known, as well as the costs of
14 this action pursuant to 15 U.S.C. § 1117(a), attorneys' fees, and treble damages.

15 **SECOND CLAIM FOR RELIEF**

16 **(False Designations of Origin and False Descriptions**

17 **pursuant to 15 U.S.C. § 1125(a)(1)(A))**

18 33. Good repeats and re-alleges paragraphs 1 through 25 of the
19 Complaint as if fully set forth herein.

20 34. Defendant appropriated the GOOD Marks for its own business name,
21 brand, and website URL without Good's consent. Such use of the GOOD Marks
22 by Defendant creates a likelihood of confusion, mistake or deception among
23 members of the public, and is likely to cause the public to believe incorrectly that
24 Good.co is affiliated with, connected to, or associated with Good, or that Good
25 originated, sponsored or approved Defendant's goods, services or commercial
26 activities, to Good's detriment.

27 35. Good is informed and believes, and upon that basis alleges, that
28 Defendant uses the GOOD Marks in its business name and website URL in a

1 deliberate and intentional effort to confuse the public as to the source of
 2 Defendant's goods or services and to reap the benefit of Good's goodwill
 3 associated with the GOOD Marks. Defendant knew or should have known that the
 4 GOOD Marks were already federally registered at the time it started infringing
 5 those marks and would have discovered the GOOD Marks had it conducted a
 6 reasonable investigation. Defendant chose a name confusingly similar to the
 7 GOOD Marks to trade off the goodwill Good established by its prominent use of
 8 the GOOD Marks for over a decade.

9 36. On September 16, 2014, Good requested that Defendant cease and
 10 desist from its acts of trademark infringement, but Defendant has refused.

11 37. It would be difficult to ascertain the amount of compensation which
 12 could afford Good adequate relief for such continuing acts. Good's remedy at law
 13 is not adequate to compensate it for the injuries threatened.

14 38. In light of the foregoing, Good is entitled to injunctive relief
 15 prohibiting Defendant from using the GOOD Marks or confusingly similar marks
 16 and to recover from Defendant all damages that Good has and will sustain as a
 17 result of such infringing acts, and all gains, profits and advantages obtained by
 18 Defendant as a result thereof, in an amount not yet known, as well as the costs of
 19 this action pursuant to 15 U.S.C. § 1117(a), attorneys' fees, and treble damages.

THIRD CLAIM FOR RELIEF

21 **(Violation of the Anticybersquatting Consumer Protection Act pursuant to 15**
 22 **U.S.C. § 1125(d))**

23 39. Good repeats and re-alleges paragraphs 1 through 25 of the
 24 Complaint as if fully set forth herein.

25 40. Good is informed and believes and upon that basis alleges that
 26 Defendant has engaged in a bad faith attempt to profit from the GOOD Marks by
 27 *inter alia*, adopting a domain name (www.good.co) that differs by one letter from
 28 Good's domain name (www.good.com).

1 41. In connection with the sale of its application software, Defendant is
 2 using a domain name that is confusingly similar to the GOOD Marks and domain
 3 name. Defendant's use is likely to cause, and most likely has caused, confusion or
 4 mistake as to the affiliation, connection, or association between Defendant and
 5 Good, or as to the origin, sponsorship, or approval of Defendant's goods and
 6 services by Good.

7 42. Moreover, Defendant's use of the good.co domain name is likely to
 8 cause consumers searching for Good's website to be diverted to Defendant's
 9 website.

10 43. Good is informed and believes and upon that basis alleges that
 11 Defendant changed its name and URL from "Manageup.Me" to "Good.co" and
 12 began using the good.co domain name to capitalize on Good's name recognition,
 13 good will and reputation.

14 44. It would be difficult to ascertain the amount of compensation which
 15 could afford Good adequate relief for such continuing acts. Good's remedy at law
 16 is not adequate to compensate it for the injuries threatened.

17 45. In light of the foregoing, Good is entitled to injunctive relief
 18 prohibiting Defendant from using the GOOD Marks or confusingly similar marks
 19 and to recover from Defendant all damages that Good has and will sustain as a
 20 result of such infringing acts, and all gains, profits and advantages obtained by
 21 Defendant as a result thereof, in an amount not yet known, as well as the costs of
 22 this action pursuant to 15 U.S.C. § 1117(a), attorneys' fees, and treble damages.

FOURTH CLAIM FOR RELIEF

(Unfair Business Practices pursuant to Cal. Bus & Prof. Code § 17200)

25 46. Good repeats and re-alleges paragraphs 1 through 25 of the
 26 Complaint as if fully set forth herein.

27 47. Defendant's actions alleged herein constitute unfair, illegal, or
 28 fraudulent business practices prohibited by California Business and Professions

1 Code section 17200 *et seq.* These actions include, but are not limited to, using the
2 GOOD Marks and a confusingly similar URL without Good's consent for
3 Defendant's pecuniary gain. As a result, Defendant is now unjustly enriched and
4 is benefitting from trademark rights that belong to Good.

5 48. Unless enjoined by the Court, Defendants will continue to take the
6 actions set forth above. Such actions will continue to cause great and irreparable
7 harm to Good.

8 49. In light of the foregoing, Good is entitled to injunctive relief
9 prohibiting Defendant from using the GOOD Marks or any confusingly similar
10 mark or URL.

11 **PRAYER FOR RELIEF**

12 WHEREFORE, Good respectfully requests judgment in its favor and
13 against Defendant as follows:

14 1. For temporary, preliminary and permanent injunctive relief
15 restraining Defendant, its agents, servants, employees, representatives,
16 shareholders, partners, joint venturers or anyone else acting on behalf of or in
17 concert with Defendant from:

- 18 a. Using the GOOD Marks;
- 19 b. Using any marks which are identical or confusingly similar to
20 that of the GOOD Marks, including use of good.co;
- 21 c. Using the good.co domain name;
- 22 d. Otherwise infringing upon Good's registered and common law
23 trademarks; and
- 24 e. Otherwise unfairly competing with Good.

25 2. For an order that Defendant file with the Court and serve upon
26 counsel for Good, within thirty (30) days of the entry of the permanent injunction
27 requested in this Complaint, a written report, sworn to under oath, setting forth in
28 detail the manner and form in which Defendant has complied with the injunction.

3. For final judgment adjudging that Defendant:

a. Has willfully engaged in trademark infringement under the Lanham Act;

b. Has committed and is committing acts of false designation of origin, false or misleading description of fact and false or misleading representation against Good;

c. Has violated the Anticybersquatting Consumer Protection Act;

d. Has engaged in unfair methods of competition in violation of California law; and

e. Has otherwise injured the business reputation and business of Good by its conduct.

4. For an order for an accounting by Defendant of all gains, profits and advantage derived from its wrongful acts;

5. For an order that Defendant disgorge its profits;

6. For an order that Defendant pay Good’s damages and Defendant’s profits trebled pursuant to 15 U.S.C. § 1117(a); and

7. For an order that Defendant pay Good applicable interest, attorneys’ fees, and costs of suit.

8. For an order awarding Good such other and further relief as the Court deems just and proper.

JURY DEMAND
