This complaint is based on the following factual and legal grounds: ICANN Rule 3(b)(ix).

- [a.] The domain name is identical or confusingly similar to a trademark or service mark in which the Complainant has rights. UDRP Rule 3(b)(ix)(1); UDRP Policy ¶ 4(a)(ii). Complainant LIFE IS NOW, INC. is in the business of professional and personal coaching. Complainant LIFE IS NOW, INC. has used the JUST BELIEVE mark since at least 2003. The "justbelieve.com" domain name is confusingly similar to the JUST BELIEVE mark.
- [b.] The Respondent (domain-name holder) should be considered as having no rights or legitimate interests in respect of the domain name that is the subject of the complaint. UDRP Rule 3(b)(ix)(2); UDRP Policy ¶ 4(c). Respondent owns the offending domain, which resolves to one of four different homepages with different domain names, attached as Exhibit B, C, D, and E. The actual domain, "justbelieve.com" could not be reached. Each offending website has "justbelieve" as part of the domain name, and identifies themselves by using "just believe" as part of their webpage name.
- [c.] The domain name should be considered as having been registered and been used in bad faith. UDRP Rule 3(b)(ix)(3); UDRP Policy ¶ 4(a)(iii) Each offending website has "justbelieve" as part of the domain name, and identifies themselves by using "just believe" as part of their webpage name. The "justbelieve.com" domain name and the "Just Believe" tags at the top of each of the websites demonstrate that Respondent has intentionally attempted to attract, possibly for commercial gain, Internet users to Respondent's website, by creating a likelihood of confusion with the Complainant's mark as to the source, sponsorship, affiliation, or endorsement of Respondent's websites or comments.

[7.] **REMEDY SOUGHT**

The Complainant LIFE IS NOW, INC. requests that the Panel issue a decision that the domain-name registration be transferred to LIFE IS NOW, INC. UDRP Rule 3(b)(x).

[8.] OTHER LEGAL PROCEEDINGS

Two other legal proceedings were filed and voluntarily dismissed in connection with or relation to the domain name that is the subject of the complaint when the ownership of the domain was transferred. They were filed in the Central District of California and are as follows: LIFE IS NOW INC. v. INTERNET.BS CORP, a business of unknown type; GREGG MCNAIR, an individual; and MARC RINUADO, an individual. Case No. 2:12-cv-10955-PSG-PLA LIFE IS NOW INC. v. FUNDACION PRIVATE WHOIS, a business of unknown type; and DOES 1 through 10 inclusive. Case No. 2:13-cv-00888-PSG-RNB UDRP Rule 3(b)(xi).

- 1. Purpose. This Uniform Domain Name Dispute Resolution Policy (the "Policy") has been adopted by the Internet Corporation for Assigned Names and Numbers ("ICANN (Internet Corporation for Assigned Names and Numbers)"), is incorporated by reference into your Registration Agreement, and sets forth the terms and conditions in connection with a dispute between you and any party other than us (the registrar) over the registration and use of an Internet domain name registered by you. Proceedings under Paragraph 4 of this Policy will be conducted according to the Rules for Uniform Domain Name Dispute Resolution Policy (the "Rules of Procedure"), which are available at http://www.icann.org/en/dndr/udrp/uniform-rules.htm (/dndr/udrp/uniform-rules.htm), and the selected administrativedispute-resolution service provider's supplemental rules.
- 2. Your Representations. By applying to register a domain name, or by asking us to maintain or renew a domain name registration, you hereby represent and warrant to us that (a) the statements that you made in your Registration Agreement are complete and accurate; (b) to your knowledge, the registration of the domain name will not infringe

upon or otherwise violate the rights of any third party; (c) you are not registering the domain name for an unlawful nurnose: and (d) you will not knowingly use the domain name in violation of any applicable laws or regulations. It is your responsibility to determine whether your domain name registration infringes or violates someone else's rights.

- 3. <u>Cancellations</u>, <u>Transfers</u>, <u>and Changes</u>. We will cancel, transfer or otherwise make changes to domain name registrations under the following circumstances:

We may also cancel, transfer or otherwise make changes to a domain name registration in accordance with the terms of your Registration Agreement or other legal requirements.

4. Mandatory Administrative Proceeding.

This Paragraph sets forth the type of disputes for which you are required to submit to a mandatory administrative proceeding. These proceedings will be conducted before one of the administrative-dispute-resolution service providers listed at www.icann.org/en/dndr/udrp/approved-providers.htm (/en/dndr/udrp/approved-providers.htm) (each, a "Provider").

- **a. Applicable Disputes.** You are required to submit to a mandatory administrative proceeding in the event that a third party (a "complainant") asserts to the applicable Provider, in compliance with the Rules of Procedure, that
 - (i) your domain name is identical or confusingly similar to a trademark or service mark in which the complainant has rights; and
 - (ii) you have no rights or legitimate interests in respect of the domain name; and
 - (iii) your domain name has been registered and is being used in bad faith.

In the administrative proceeding, the complainant must prove that each of these three elements are present.

b. Evidence of Registration and Use in Bad Faith. For the purposes of Paragraph 4(a)(iii), the following circumstances, in particular but without limitation, if found by the Panel to be present, shall be evidence of the registration and use of a domain name in bad faith:

(i) circumstances indicating that you have registered or you have acquired the domain name primarily for the purpose of selling, renting, or otherwise transferring the domain name registration to the complainant who is the owner of the trademark

excess of your documented out-of-pocket costs directly related to the domain name; or

- (ii) you have registered the domain name in order to prevent the owner of the trademark or service mark from reflecting the mark in a corresponding domain name, provided that you have engaged in a pattern of such conduct; or
- (iii) you have registered the domain name primarily for the purpose of disrupting the business of a competitor; or
- (iv) by using the domain name, you have intentionally attempted to attract, for commercial gain, Internet users to your web site or other on-line location, by creating a likelihood of confusion with the complainant's mark as to the source, sponsorship, affiliation, or endorsement of your web site or location or of a product or service on your web site or location.
- c. How to Demonstrate Your Rights to and Legitimate Interests in the Domain Name in Responding to a Complaint. When you receive a complaint, you should refer to Paragraph 5 (/dndr/udrp/uniform-rules.htm#5) of the Rules of Procedure in determining how your response should be prepared.  - (i) before any notice to you of the dispute, your use of, or demonstrable preparations to use, the domain name or a name corresponding to the domain name in connection with a bona fide offering of goods or services; or
 - (ii) you (as an individual, business, or other organization) have been commonly known by the domain name, even if you have acquired no trademark or service mark rights; or
 - (iii) you are making a legitimate noncommercial or fair use of the domain name, without intent for commercial gain to misleadingly divert consumers or to tarnish the trademark or service mark at issue.
- **d. Selection of Provider.** The complainant shall select the Provider from among those approved by ICANN (Internet Corporation for Assigned Names and Numbers) by submitting the complaint to that Provider. The selected Provider will administer the proceeding, except in cases of consolidation as described in Paragraph 4(f).
- **e.** Initiation of Proceeding and Process and Appointment of Administrative Panel. The Rules of Procedure state the process for initiating and conducting a proceeding and for appointing the panel that will decide the dispute (the "Administrative Panel").
- **f. Consolidation.** In the event of multiple disputes between you and a complainant, either you or the complainant may petition to consolidate the disputes before a single Administrative Panel. - k. Availability of Court Proceedings. If an Administrative Panel decides that your domain name registration should be canceled or transferred, we will wait ten (10) business days (as observed in the location of our principal office) after we are informed by the applicable Provider of the Administrative Panel's decision before implementing that decision. We will then implement the decision unless we have received from you during that ten (10) business day period official documentation (such as a copy of a complaint, file-stamped by the clerk of the court) that you have commenced a lawsuit against the complainant in a jurisdiction to which the complainant has submitted under Paragraph 3(b)(xiii) (/dndr/udrp/uniform-rules.htm#3bxiii) of the Rules of Procedure. (In general, that jurisdiction is either the location of our principal office or of your address as shown in our Whois database. See Paragraphs 1 (/dndr/udrp/uniform-rules.htm#1MutualJurisdiction) and 3(b) (xiii) (/dndr/udrp/uniform-rules.htm#3bxiii) of the Rules of Procedure for details.) - 5. <u>All Other Disputes and Litigation</u>. In the event that you transfer a domain name registration to us during the pendency of a court action or arbitration, such dispute shall remain subject to the domain name dispute policy of the registrar from which the domain name registration was transferred.
- 9. Policy Modifications. We reserve the right to modify this Policy at any time with the permission of ICANN (Internet Corporation for Assigned Names and Numbers). We will post our revised Policy at <URL (Uniform Resource Locator)> at least thirty (30) calendar days before it becomes effective. Unless this Policy has already been invoked by the submission of a complaint to a Provider, in which event the version of the Policy in effect at the time it was invoked will apply to you until the dispute is over, all such changes will be binding upon you with respect to any domain name registration dispute, whether the dispute arose before, on or after the effective date of our change. In the event that you object to a change in this Policy, your sole remedy is to cancel your domain name registration with us, provided that you will not be entitled to a refund of any fees you paid to us.
